Stanford Basic income Lab (BIL)

In February 2017, I launched the Stanford Basic Income Lab which provides an academic home for the study of Universal Basic Income as a measure to alleviate poverty and inequalities. BIL hires graduate and postdoctoral fellows who produce research on UBI, advises those developing UBI policies and carrying out UBI experiments, aggregates and disseminates research findings, and convenes scholars, policy makers, and leaders in business, think tanks, nonprofits, and foundations around the Philosophy, Politics and Economics of UBI. Since 2021, I am co-PI at the Center for Guaranteed Income Research, overseeing the dissemination of data coming out of 30+ pilots.
